Please Note:

- All workshops and trainings are approved by Pro-EFW but provided by independent Pro-EFW Trainers who determine their fees. All Trainers will teach Pro-EFW’s principles and Code of Ethics, but each trainer has his/her individual approach and method to working in the field of equine facilitated wellness. Please research the different trainers to determine which approach is best suited to you. You may take the Explorations training with any of the 3 Pro-EFW Trainers but Focus and Integration training must be taken with the same Pro-EFW Trainer.
- Ten hours of Mentorship are required during the certification process. Hourly fees for mentorship are set up on an individual basis with your Pro-EFW Trainer or Mentor.
